## Dhaka, the 6th July 1986

No. S.R.O. 273-L/86-IX/F-2/86(ii).—In exercise of the power conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P.Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sections 4, 8, 10 and 11 of the said Act in respect of the establishments specified in the Schedule below for a period of six months subject to the following conditions, namely:—

- (a) the workers required to work overtime shall be paid wages at double the rate of ordinary wages for working beyond the normal working hours; and
- (b) the workers deprived of weekly holidays shall be allowed compensatory weekly holidays within next six months.
