Dacca, the 7th October, 1978.

No. S.R.O. 277-L/78/448/D/CUS.—In exercise of the powers conferred by section 16 of the Customs Act, 1969 (IV of 1969), the Government is pleased to prohibit the bringing into Bangladesh by air, sea or land any copy of the book titled "Civilization Past and Present" in English, published by Scott, Foresman and Company, Glenview Illinois 60025, U.S.A. or any other book, papers or document containing copies, reprints or translations of, or extracts from, the said book.

No. S.R.O. 278-L/78/449/D/Cus.—In exercise of the powers conferred by section 16 of the Customs Act, 1969 (IV of 1969), the Government have decided to prohibit the bringing into Bangladesh by air, sea or land any copy of a book called "Midnight Massacre in Dacca" in English written by Sukharanjan Das Gupta and published by Vikas Publishing House (Private) Limited, New Delhi, India or any other book, paper or document containing copies, reprints or translations of or extracts from, the said book.

No. S.R.O. 279-L/78/453/D/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to exempt the articles falling under the Heading Nos. specified in the Table I of this Ministry's Notification No. S.R.O. 244-L/78/447/D/Cus., dated the 18th September, 1978, except the articles enumerated in the Table below from so much of the customs-duties leviable the con as is in excess of 25% *ad val.* provided these are machinery as defined in the aforesaid Notification or spare parts of, or articles for use with, such machinery, subject to the following conditions, namely:—

- (i) the articles are identifiable as for use only with machinery and have been given for that purpose some special shape, size or quality;
- (ii) it is established to the satisfaction of an officer of customs not below the rank of an Assistant Collector that the articles are used as aforesaid; and
- (iii) no duty of customs has been imposed on the articles under the Protective Duties Act, 1950 (LXI of 1950), nor has the duty of customs

imposed on the articles been changed under the said Act into a protective one.
