Dacca, the 22nd August, 1977.

No. S.R.O. 280-L/77.—In exercise of the powers conferred by the proviso to Article 133 of the Constitution of the People's Republic of Bangladesh, the President, after consultation with the Public Service (First) Commission and the Public Service (Second) Commission, as required by clause (2) of Article 140 of that Constitution, is pleased to make the following rules, namely:—

THE GAZETTED OFFICERS (DEVELOPMENT PROJECT UNDER THE GEOLOGICAL SURVEY OF BANGLADESH) RECRUITMENT RULES, 1977.

1. **Short title.**—These rules may be called the Gazetted Officers (Development Project under the Geological Survey of Bangladesh) Recruitment Rules, 1977.

2. **Definitions.**—In these rules, unless there is anything repugnant in the subject or context,—

(a) “appointing authority” means the Government and includes, in relation to any specified post or class of such posts, any officer authorised by the Government to make appointment to such post or class of posts;

(b) “Commission” means,—

(i) in the case of a specified post declared by the Government to be a class I post, the Public Service (First) Commission; and

(ii) in the case of any other specified post, the Public Service (Second) Commission;

(c) “departmental promotion committee” means,—

(i) in the case of a specified post declared by the Government to be a class I post, the departmental promotion committee constituted in that behalf in the Establishment Division; and

(ii) in the case of any other specified post, the departmental promotion committee constituted in the Ministry of Petroleum and Minerals;

- (d) "recognised university" means a university established by or under any law for the time being in force and includes any other university declared by the Government, after consultation with the Commission, to be a recognised university for the purpose of these rules;
- (e) "requisite qualification", in relation to a specified post, means the qualification specified in column 5 of the Schedule in relation to that post;
- (f) "Schedule" means the Schedule annexed to these rules; and
- (h) "specified post" means a post specified in the Schedule.

3. **Procedure for recruitment.**—(1) Subject to the provisions of the Schedule and such instructions relating to reservation for the purpose of clause (3) of Article 29 of the Constitution as may be issued, appointment to a specified post shall be made by direct recruitment.

(2) No person shall be appointed to a specified post unless he has the requisite qualification and is also within the age limit, if any, laid down in the Schedule for that post.

(3) Notwithstanding anything contained in these rules, the Government may, in consideration of experience and merit and with the concurrence of the Commission, relax, in any exceptional case the age limit, if any, specified in the Schedule to such extent as it may deem fit.

4. **Appointment by direct recruitment.**—(1) No appointment to a specified post by direct recruitment shall be made except on the recommendation of the Commission.

(2) No person shall be eligible for appointment to a specified post by direct recruitment, if he—

- (a) is not a citizen or permanent resident of Bangladesh;
- (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.

(3) No appointment to a specified post by direct recruitment shall be made until—

- (a) the person selected for appointment is certified by a Medical Board set up for the purpose by the Government to be medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the post;
- (b) the antecedents of the person so selected have been verified through appropriate agencies and found to be such as do not render him unfit for appointment in the services of the Republic.

5. **Probation.**—(1) Persons selected for appointment to a specified post against a substantive vacancy shall be appointed on probation for a period of two years from the date of substantive appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period does not exceed two years in the aggregate.

(2) After the completion of the period of probation or the extended period thereof, the appointing authority—

(a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall, subject to the provisions of sub-rule (3), confirm him if the post is declared permanent by the Government; and

(b) if it is of the opinion that the conduct and work of the probationer during that period was not satisfactory, may terminate his service.

(3) A probationer shall not be—

(a) confirmed in a specified post, or

(b) promoted to the next higher specified post, unless he has passed such departmental examination as the Government may, from time to time, direct within four years from the date of substantive appointment.
