নং এস, আর, ও ২৮৫-আইন—Wireless Telegraphy Act, 1933 (XVII of 1933) এর Section 10 এ প্রদত্ত ক্ষমতাবলে সরকার Television Receiving Apparatus (Possession and Licensing) Rules, 1970 এর নিম্নরূপ অধিকতর সংশোধন করিলেন, যথাঃ—

উক্ত, Rules এর,—

(১) Rules, ২ তে,—

(ক) clause (g)তে, “Director-General of the National Broadcasting Authority (Television Wing)” শব্দগুলি ও বন্ধনীগুলির পরিবর্তে “Chairman, National Broadcasting Authority” শব্দগুলি ও কমা প্রতিস্থাপিত হইবে; এবং

(খ) clause (h) বিলুপ্ত হইবে,

(২) rule 3 এর—

(ক) sub-rule (2) এর পরিবর্তে নিম্নরূপ sub-rule প্রতিস্থাপিত হইবে, যথাঃ—

“(a) A holder in possession of a television receiving apparatus or video cassette recorder who brings it from abroad or buys from a duty-free shop shall make an application not later than three office working days from the date of bringing it from abroad or buying it from a duty-free shop;

- (b) A holder in possession of a television receiving apparatus or video cassette recorder licensed under these Rules shall get his licence renewed by the 31st December, each year, unless the time for renewal is extended by the Licensing Authority”;

(খ) sub-rule (3)-এর clauses (a), (b), (c) and (d) এর পরিবর্তে নিম্নরূপ clause সমূহ প্রতিস্থাপিত হইবে, যথা:

“(a) if the holder is a user for non-commercial purpose,—

- (i) in the case of a television receiving apparatus capable of receiving the telecast in black and white, taka one hundred and twenty-five if paid on annual basis; taka five hundred if paid at a time for five years; and taka eleven for each month if the licence is obtained for a period of less than a year; and  
(ii) in the case of a television receiving apparatus capable of receiving the telecast in colour, taka three hundred if paid on annual basis; taka one thousand and two hundred if paid at a time for five years; and taka twenty-five for each month if the licence is obtained for a period of less than a year;

- (b) if the holder is a user for commercial purpose and is either a dealer or a seller or an assembler, taka one thousand and six hundred annually; and taka one hundred and thirty-four for each month if the licence is obtained for a period of less than a year;
- (c) if the holder maintains the television receiving apparatus for commercial purpose either in a hotel or restaurant or elsewhere or if the holder runs a shop for repairing or selling parts and spare parts of such apparatus, taka nine hundred annually; and taka seventy-five for each month if the licence is obtained for a period of less than a year; and
- (d) if the holder maintains a video cassette recorder, taka five hundred if paid on annual basis; taka two thousand if paid at a time for five years; and taka forty-two for each month if the licence is obtained for a period of less than a year.

*Explanation.*—For the purpose of calculation of fee for a month under this sub-rule, any period less than a month shall be reckoned as a full month.”.

(৩) rule 4 এর পরিবর্তে নিম্নরূপ rule 4 প্রতিস্থাপিত হইবে, যথা:

“4. Each licence shall bear an embossed seal approved by the Licensing Authority and shall issued in the relevant form mentioned below :—

- (a) in the case of a television receiving apparatus capable of receiving the telecast in black and white, in Form II (for one year) and in Form III (for five years);

- (b) in the case of a television receiving apparatus capable of receiving the telecast in colour, in Form IV (for one year) and in Form V (for five years);
- (c) in the case of a video cassette recorder, in Form VI (for one year) and in Form VII (for five years);
- (d) in the case of a licence issued to a dealer or a seller or an assembler to a television receiving apparatus, in Form VIII; and
- (e) in the case of a television receiving apparatus maintained for commercial purpose either in a hotel or restaurant or elsewhere or a shop run for repairing or selling parts or spare parts thereof, in Form IX."
