NOTIFICATION

Dacca, the 11th October, 1979.

No. S.R.O. 288-L/79.—In exercise of the powers conferred by the Explanation to sub-section (2C) of section 14A of the Income-tax Act, 1922 (XI of 1922), the National Board of Revenue is pleased to specify the following standard to be the standard of a tourist industry for purposes of the said Explanation, namely :—

- (1) The number of guest-rooms should not be less than 60 (sixty) in case the industry is located in Dacca and Chittagong, and 30 (thirty) in cass it is located in other places; and each such industry should have adequate public facilities, such as, dining hall, lobbying space, etc.;
- (2) Each guest-room should have an attached bath room equipped with modern sanitary fittings;
- (3) At least 50% of the guest-rooms should be airconditioned;
- (4) Each guest-room should be fitted with a telephone or there should be at least one telephone for each floor:

Provided that the National Board of Revenue may relax one or more of the aforesaid standards in case of an industry located in places other than in Dacca and Chittagong.
