is pleased to make the following further amendment in the Ministry of Finance Notification No. S.R.O. 120(1)/70, dated the 29th June, 1970, namely:—

In the aforesaid Notification, for item No. 14 and the entries relating thereto the following shall be *substituted*, namely:—

“14. Imported iron or steel wire but excluding the following:—

bright steel wire of the chemical composition described in the Table given below and falling under heading No. 73·14 of the First Schedule to the Tariff Act, 1934 (XXXII of 1934) when imported by recognized manufacturers of wood screws, roofing screws, bolts, nuts and machine screws and cleared against their Pass Book entitlement:
