NOTIFICATION

Dacca, the 24th September 1981

No. S.R.O. 324-L/81.—In exercise of the powers conferred by Article 19 of the Bangladesh Rifles Order, 1972 (P.O. No. 148 of 1972), read with clause (3) of Article 5 of the said Order, the Government is pleased to make the following amendments in the Superior Officers (Bangladesh Rifles) Recruitment Rules, 1980, namely:—

In the aforesaid Rules,—

- (a) in rule 3, in sub-rule (1) for the full-stop at the end a colon shall be *substituted* and thereafter the following proviso shall be *added*, namely:—

“Provided that appointment to the specified posts of Deputy Director, Assistant Director and Deputy Assistant Director in the Medical Department shall be filled up by transfer on deputation of Officers of the Army Medical Corps.”;

(b) in the Schedule,—

- (i) for the figure “ $\frac{1}{3}$ ” wherever occurring the words and figure “Not more than “ $\frac{1}{3}$ ” shall be *substituted* in all the places; and
- (ii) for the figure “ $\frac{2}{3}$ ” wherever occurring the words and figure “Not less than “ $\frac{2}{3}$ ” shall be *substituted* in all the places; and

(c) against Sl. No. 6 in the first column; in the fourth column, for clause (a) the following shall be *substituted*, namely:—

“(a) Must have put in at least three years’ service as Subedar Major or five years’ service as Subedar or seven years’ service as Naib Subedar or a total of not less than seven years’ service in two or more of the abovementioned classes of posts;”
