#### MINISTRY OF FOOD

#### NOTIFICATION

Dadca, the 16th November, 1977.

No. S.R.O. 339-L/77/MF/S-7/1F-29/77/835.—In exercise of the powers conferred by sub-clauses (1) and (2) of clause 7 of the Foodstuffs Price Control and Anti-Hoarding Order, 1953, and in supersession of all previous Notifications issued in this regard, the Government is pleased to direct that—

- (a) no wholesaler of mustard oil, rapeseed oil, cotton seed oil or soyabean oil shall keep in his possession or under his control more than one hundred and fifty maunds of such oil at a time whether imported or produced locally, for more than fifteen days from the date of its importation or purchase or production by him;
- (b) no retailer of mustard oil, cotton seed oil, soyabean oil or rapeseed oil shall keep in his possession or under his control more than twenty maunds of such oil at a time for more than fifteen days from the date of its purchase by him;
- (c) no oil mill shall keep in its possession or under its control mustard seeds, cotton seeds or rapeseeds in excess of the installed capacity of such mill for more than fifteen days at a time;
- (d) no wholesaler (other than oil mill owners) of mustard seeds, cotton seeds or rape seeds shall keep in his possession or under his control more than five hundred maunds of such seeds at a time for more than fifteen days from the date of their importation or purchase by him:

(e) no retailer of mustard seeds, cotton seeds or rape seeds shall keep in his possession or under his control more than fifty maunds of such seeds at a time for more than fifteen days from the date of their importation or purchase by him.

#### NOTIFICATIONS

Dacca, the 16th November, 1977.

No. S.R.O. 340-L/77.—In exercise of the power conferred by section 2(a) (XXIV) of the Control of Essential Commodities Act, 1956 (E.P. Act I of 1956), the Government is pleased to declare onion and chillies as essential commodities for the purposes of the said Act.

- No. S.R.O. 341-L/77.—In exercise of the power conferred by section 3 of the Control of Essential Commodities Act, 1956 (E.P. Act I of 1956), the Government is pleased to make the following Order, namely:—
- 1. Short title.—This Order may be called the Onion and Chillies (Storage) Order, 1977.
- 2. Quantity of onion to be kept by a wholesaler and retailer.—(1) No wholesaler of onion shall retain in his possession or under his control more than ten maunds of onion at a time for more than seven days from the date of its importation or purchase by him.
- (2) No retailer of onion shall retain in his possession or under his control more than two maunds of onion at a time for more than seven days from the date of its purchase by him.
- 3. Quantity of chillies to be kept by a wholesaler and retailer.—(1) No wholesaler of chillies shall retain in his possession or under his control more than five maunds of chillies at a time for more than seven days from the date of their importation or purchase by him.
- (2) No retailer of chillies shall retain in his possession or under his control more than one maund of chillies at a time for more than seven days from the date of their importation or purchase by him.
