In Pursuance of the Mongla Port Authority ordinance no . LIII of 1976 and the Mongla Port Authority (Amendment) Ordinance, 1982 and 1987 under sub-section 1 & 2 of section 19 in supersession of all other previous notifications on the subjects , the following charges have been framed by the Mongla Port Authority approved by the Ministry of Finance & Ministry of Shipping of Government of the people's Republic of Bangladesh vide Memo No. ০৭.০০. ০০০০. ১৪৪.০৫২.১১৮.২০১৩ (অংশ)-২২, তাং-০৮-১২-২০১৯ & ১৮.০০.০০০০.০২২. ১৭.০০১.১৬.০৫, তাং-০৫-০১-২০২০ respectively. The following Tariff charges will effect from 30.01.2020.

For LCL, this tariff covers the movement of container between jetty and storage area and to and from the point of stuffing/un-stuffing, extra movements, such as stacking or restacking carried out for MPA convenience are included.

ii) Over height containers shall be charged at one and a half times the loading or discharging rate. Over height containers are in excess of nine feet high.

iii) Open top or flat or side open or overweight or over dimensional empty container/such loaded container having projected cargo shall be charged at two times the loading/ discharging rate.

iv) Due to non availability of MPA equipment if authority asks any shipping agent /owner of the vessel to use their own equipment to assist in loading or discharging, the charges shall be 70% of the rate shown. This is applicable for handling of container from hook point to container yard or vice versa in MPA protected area. For LCL loading/discharging, this rebate shall be given on the basis of FCL rate shown.
