O. 369-L/77/14-Excise.—In exercise of the powers conferred by the provisions contained in the third column against item No. 811 (2)(i) in the first column of the first Schedule to the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to direct that the following further amendment shall be made in this Ministry's notification No. S.R.O. 214-L/75/10/75-Excise, dated the 23rd June, 1975, namely:

In the aforesaid Notification, in the Table, in serial No. 7, in column 1, for entries (a) and (b) in column 3 and the entries relating thereto in column 4, the following shall be substituted, namely:—
