(Customs and Sales Tax)

ORDER

Dhaka, the 19th August, 1984

No. S.R.O. 390-L/84/872/Cus.—In exercise of the powers conferred by clause (c) of section 21 of the Customs Act, 1969 (IV of 1969), and section 5A of the Sales Tax Ordinance, 1982 (XVIII of 1982), the National Board of Revenue is pleased to authorise repayment of the customs-duties paid in excess of 20% and whole of sales tax on importation of raw rubber and re-claimed rubber, synthetic rubber, thermoplastic moulding compounds, rubber pasting, shoe grindery (shoe tacks), cotton, nylon, linen thread, chalk and clay (china clay) and chemicals thereof for the manufacture of boot-sole by M/s. Bangladesh Civil and Military Boot Factory, Dhaka, within their annual entitlement, subject to the following conditions, namely:—

- (a) that the repayment shall only be made on items imported within the annual entitlement of the unit concerned, as determined by the Department of Industries;
- (b) that the repayment claim shall be submitted within two years from the date of importation of the raw materials;
- (c) that the repayment application shall accompany a certificate issued by the Director-General of Industries, certifying its use in the manufacture of the boot-sole for manufacture of army-type boots; and
- (d) that the repayment shall be effected, on the basis of Expeditious Repayment of Customs Duty and Sales Tax Rules, 1984.

No. S. R. O. 394-L/84.—In exercise of the powers conferred by section 20 of the Jute Ordinance, 1962 (LXXIV of 1962), the Government is pleased to make the following further amendments in the Jute (Licensing and Enforcement) Rules, 1964, namely:—

In the aforesaid Rules,—

(1) in Schedule I, for serial 7 and the entries relating thereto, the following shall be *substituted*, namely:—

- "7. Exporter of Jute Manufactures .. (a) Taka 10,000 for export of jute manufactures other than jute carpet;
- (b) Taka 1,000 for export of jute carpet;

The above rates of fees for Exporter of jute manufactures shall be effective in respect of licences to be issued or renewed for the financial year 1984-85 and subsequent years."

(2) in Schedule II, in the Application Form No. JA(II), for serial (3) and the entries relating thereto, the following shall be *substituted*, namely:—

"(3) Nature of business (whether exporter of jute or exporter of jute manufactures. If exporter of jute manufactures, whether for export of jute manufactures other than jute carpet or for export of only jute carpet)."; and

- (3) in Schedule III, in Licence Form No. JB(II), for the entries in the heading of column 3 the following shall be *substituted*, namely:—

“Nature of business (whether exporter of jute or jute manufactures. If exporter of jute manufactures, whether for export of jute manufactures other than jute carpet or for export of only jute carpet).”
