NOTIFICATION

Dhaka, the 8th December 1982

No. S. R. O. 412-L/82/S-X/M-19/82.—In exercise of the powers conferred by clause (b) of section 32 of the Paurashava Ordinance, 1977 (Ord. XXVI of 1977), the Government is pleased to direct that the Dhaka Mosquito Control Scheme of the Government (hereinafter referred to as the "Scheme") alongwith the officers and other employees working thereunder shall stand transferred to the management and control of the Dhaka Municipal Corporation (hereinafter referred to as the "Corporation") on the following terms and conditions, namely:

1. The Scheme shall be administered and controlled by the Corporation in such manner as the Government may direct from time to time.

2. The officers and other employees of the Scheme, now transferred to the Corporation (hereinafter referred to as the "officers and other employees" or "an officer or other employee", as the case may be) shall be treated as transferred Government employees on foreign service terms and condition and their services under the Corporation shall be regulated by the foreign service rules laid down in the Bangladesh Service Rules, Part I. The Government may recall any such officer or other employee in the interest of public service whenever it deems necessary, but the Corporation shall not replace his service under the Scheme without the previous approval of the Government.

3. An officer or other employee shall receive the pay and allowances not less than what he was drawing or would have been drawing under the Government on the date of his transfer with such increments as would have been due to him from time to time.

4. An officer or other employee shall continue to be on the same scale of pay was under the Government, if he is appointed to an analogous post under the Corporation:

Provided that if the service of an officer or other employee in the post under the Corporation involves a decided increase in duties and responsibilities, he may, with the previous approval of the Government, be granted a suitable increase in pay.

5. Subject to the prior approval of the Government, the Corporation may promote an officer or other employee to any higher post and his pay in such higher post shall be in the scale of the corresponding post, if there be any, under the Government, if not, then in the scale of pay of the post sanctioned by the Corporation, provided that the initial pay in the higher post shall not be less than what he was drawing or would have been drawing under the Corporation had he continued in his former post.

6. An officer or other employee shall be allowed to count the service rendered by him under the Corporation for pension and the Corporation shall pay contribution to the Government for his pension according to the rates prescribed in rule 104 of the Bangladesh Service Rules, Part I.

7. The Corporation shall pay the leave salary of an officer or other employee in accordance with the rules applicable to him, whether such leave was earned while he was serving under the Government or under the Corporation, provided that leave earned for service under the Corporation shall exhausted first. The Corporation may obtain reimbursement from the Government of amount paid by it as leave salary for the period of leave due to an officer or other employee on the date of his transfer, provided that the rate of leave salary to be reimbursed shall be limited to the rate of leave salary that he would have received on the date of his transfer had he proceeded on leave on that date.

8. Notwithstanding anything contained in the Bangladesh Service Rules or in any other rules, no contribution on account of leave salary of an officer or other employee shall be paid to the Government by the Corporation.

9. The Corporation shall furnish, in such form as may be prescribed, to the Accountant-General of the Government a history of service of the Gazetted Officers showing the emoluments drawn by them from time to time, and annual establishment return of the non-Gazetted employees as it stands on the first day of each financial year.

10. The Corporation may post or transfer an officer or other employee anywhere within its jurisdiction and grant him leave and increment, and allow him to cross the efficiency bar. Copies of such orders in respect of the Gazetted Officers shall be sent to the Government and to its Accountant-General for information. Orders sanctioning leave and increments, and of crossing the efficiency bar in respect of the non-Gazetted employees shall be noted in the service book of the persons concerned under proper attestation.

11. An Officer or other employee shall continue to be eligible for admission into the Government Provident Fund like other Government Servants and the provisions of the Government Provident Fund rules shall apply to him.

12. The Accountant-General of the Government shall maintain accounts of the Fund referred to in the foregoing paragraph and may empower the Corporation to sanction advances from the said Fund and draw and disburse the amount accumulated therein. The Corporation shall recover the advance, in accordance with the General Provident Fund Rules, under intimation to the Accountant-General. In regard to the final payment of the amount in deposit, the Account-General may empower the Corporation to draw and disburse the amount in accordance with the rules of the Fund.

13. No post held by an officer or other employee in a cadre or cadres under the Government shall be abolished until the incumbent thereof resigns, retires or dies or his service is otherwise terminated.

14. An officer or other employee shall be under the administrative control of the Corporation but shall, except as otherwise specifically provided for in this notification, continue to be governed by the appropriate rules made by the Government with regard to his service conditions and disciplinary matters.

15. An officer or other employee shall not be transferred to any other department or body or institution without the prior approval of the Government.

16. An officer or other employee shall be entitled to such medical, house-rent, conveyance and other allowances and facilities as are admissible to the officers and other employees of the Corporation.

17. An officer or other employee shall have the benefit of his past services rendered under the Government for the purposes of increment and leave, if there be no break in service.

18. The past services of the work-charged employees of the Scheme, now transferred to the Corporation, shall be counted for increment to such extent as may be admissible under rule 42 of the Bangladesh Service Rules, Part-I, but they shall have no benefit of their past services rendered under the Government for the purposes of leave and pension.

No. S.R.O. 413-L/82/76-Excise.—In exercise of the powers conferred by sub-section (1) of section 12A of the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to exempt such additional production of manufacturing

units in respect of the following goods specified in the First Schedule to the said Act, from the payment of twenty-five per cent. of the excise duty leviable thereon as may be produced in excess of the yearly sanctioned capacities of the respective manufacturing units as determined by the Industries Division and communicated to the National Board of Revenue, namely:—
