- **S.R.O.** No. 92-Law/2007.—In exercise of the powers conferred by section 30 of the Fertilizer (Management) Act, 2006 (Act No. VI of 2006), the Government is pleased to make the following rules, namely:—
- 1. Name of the rules.—These rules may be called the Fertilizer (Management) Rules, 2007.
- 2. **Definitions.**—(1) In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "Act" means the Fertilizer (Management) Act, 2006 (Act No. VI of 2006);
 - (b) "Appellate Authority" means the Secretary, Ministry of Agriculture;
 - (c) "Registration Authority" means the Registration Authority as mentioned in rule 3 of these rules;
 - (d) "Schedule" means the Schedule attached with these rules; ¹[***]
 - (e) "Prescribed Form" means the Form Attached with these rules ²[;
 - (f) "registration certificate" means the registration certificate issued to the applicant to produce, import, preserve, distribute, market, transport or sell fertilizer under rule 4 of these rules.]

- 3. **Registration Authority.**—For the purpose of section 2(9) of the Act, the Registration Authority shall be the Director General of the Department of Agricultural Extension.
- 4. **Application for registration and issuing registration.**—(1) If any person intends to produce, import, preserve, distribute, market, transport or sell any type of fertilizer, he shall have to apply for registration of the said fertilizer in the Form mentioned below, namely:—

(3)	Application for registration of preservation, distribution, marketing, transportation and sale of fertilizer	Form-3
(4)	Application for renewal of registration	Form-4

- (2) The following documents and information shall be furnished along with the application referred to in sub-rule (1), namely:—
 - (a) 5 (five) copy passport size photographs;
 - (b) Nationality Certificate;
 - (c) photocopy of passport;
 - (d) attested copy of Trade License;
 - (e) attested copy of Tax Identification Number (TIN) Certificate;
 - (f) attested copy of Value Added Tax Registration Certificate;
 - (g) Bank Certificate as evidence of financial solvency; and
 - (h) overall planning for the investment along with the details of the place of the fertilizer management, office accommodation, the money to be invested in the business, and the list of the modern communication tools and machineries, such as: Fax, Phone, Internet Connection, etc. with other necessary documents in support of the other facilities.

- (3) The sample of the fertilizer shall be provided along with the application as referred to in sub-rule (1) and the sample of the fertilizer provided with the application shall cause to be tested in the laboratory designated under section 27 of the Act.
- (4) The Registration Authority shall, upon receiving the application under sub-rule (1), assign an Inspector to verify the genuineness of the information mentioned in the application and ask him to submit a report thereon in writing.
- (5) The Inspector assigned under sub-rule (4) shall make a physical inspection of the place mentioned in the application and, upon examination of the information and inquiring into all the matters, submit a complete report in this behalf to the Registration Authority within 60 (sixty) days from the date of assignment.
- (6) After receiving the report under sub-rule (5), the Registration Authority shall give its decision on the matters of application within a period not exceeding 15 (fifteen) days.
- (7) If the Registration Authority decides to issue a registration certificate to the applicant, it shall issue the registration certificate in favour of the applicant in "Form-5" as referred to in the Schedule.
- (8) If the Registration Authority decides to reject the application of an applicant, it shall convey it to the applicant by a letter within 7 (seven) days of the decision.
- (9) The applicant aggrieved by the decision of the Registration Authority may prefer an appeal against the said decision to the Appellate Authority within 15 (fifteen) days receiving the letter under sub-rule (8).
- (10) After receiving the applicant under sub-rule (9), the Appellate Authority shall dispose of it after giving the applicant an opportunity of being heard and, in this regard, the decision of the Appellate Authority shall be deemed to be final.

- 5. **Disqualifications.**—An application shall not be considered for registration on the ground of the following faults, such as:—
 - (a) if the application is incomplete or contains wrong information;
 - (b) if the registration of the applicant is previously suspended or cancelled; and
 - (c) if the applicant is convicted of any offence committed under the Fertilizer (Control) Order, 1999 or the Fertilizer (Management) Act, 2006 or these rules within preceding 3 (three) years from the date of application.
- 6. **Determination of registration and renewal fee and security money.**—(1) The registration fee under these rules shall be Taka ³[10 (Ten) Thousand].
- (2) The renewal fee of registration shall be Taka ⁴[5 (Five) Thousand] and every registration holder desiring to renew the registration shall have to apply to the Registration Authority in "Form-4".
- (3) S sum of Taka ⁵[20 (Twenty) Thousand] shall be deposited as security fee for obtaining registration certificate.
- 7. **Validity period of registration.**—(1) The registration certificate issued under sub-rule (7) of rule 4 shall have effect for ⁶[2 (Two) years]. from the date of issuance.
- 8. **Inspector.**—For the purpose of section 9 (1) of the Act, the Upazilla Agricultural Officers, the Additional Agricultural Officers and the Agricultural Extension Officers working in the Department of Agricultural Extension shall perform duties as Inspectors.

- 9. **Filling of case.**—While making inspection under section 9(2) of the Fertilizer (Management) Act, 2006, the Inspector may, on behalf of the Government, file a case against the persons violating the law related to fertilizer under section 9(3)(e) of the Act.
- 10. Constitution of the Fertilizer Import Inspection Committee.—The Government shall, by office order, constitute an "Inspection Committee" consisting of the following members in each port under section 11(4) of the Act, for the purpose of collecting sample and accelerating analysis and removing defect in fertilizer at the time of releasing fertilizer or fertilizer like raw materials imported in the sea, land or air ports, namely:—

- 11. **Import of specimen fertilizer**.—(1) Maximum 20 KG of granular/powder fertilizer and maximum 10 liters of liquid fertilizer can be imported under the proviso of section 11(1) of the Act.
- (2) In the case of importing specimen fertilizer, the same terms and conditions shall be followed as are followed in the case of importing fertilizer.
- (3) In the event of importing of specimen fertilizer, a letter of evidence of using the fertilizer in other countries and a certificate regarding its utilities in the agriculture of Bangladesh issued by the producer shall be submitted.

- 12. **The terms of reference of the Inspection Committee.**—The terms of reference of the Inspection Comittee under section 11(5) of the Act shall be as follows, namely:—
 - (a) to verify whether the imported fertilizer or substance identical with fertilizer or raw materials thereof has been imported according to law following a report made to the Inspection Committee by the importer after arriving the same in the port;
 - (b) to ensure whether the imported fertilizer or substance identical with fertilizer or raw materials thereof is ordered by the Government;
 - (c) to check and verify whether the attested copy of guaranteed analysis of the imported fertilizer and Bank L/C thereof are furnished;
 - (d) to ensure whether the importer is registered with 'DAE';
 - (e) if the imported fertilizer is ordered by the Government and the importer is registered with 'DAE', to collect the sample as per rules and send it to at least three public laboratories for testing;
 - (f) if the result of tests of at least two laboratories out of the tests conducted in three laboratories conforms with the results specified by the Government, to issue clearance order for releasing the fertilizer;
 - (g) if the result of the test does not conform with the results specified by the Government, to make order for taking action as per section 14(5) of the Fertilizer (Management) Act, 2006; and
 - (h) if this committee holds that the fertilizer or substance identical with fertilizer or raw materials thereof has been imported in contravention with any provision of the Act or these rules, to hold up unloading of the fertilizer or substance identical with fertilizer or raw materials thereof from any ship or vessel, as the case may be, and instantly report it to the concerned authority.

- 13. Destruction of any fertilizer, substance identical with fertilizer or raw materials beyond specification or environment polluting.—(1) if, upon testing of the sample, it is proved that the fertilizer or substance identical with fertilizer or raw materials thereof is beyond specification or environment polluting, the concerned producer, preservator, marketer or distributor of the fertilizer or the person having possession thereof shall take measures under section 14(5) of the Act.
- (2) In the case of noncompliance of the provision of sub-rule (1), action shall be taken in the manner prescribed in section 14(7) of the Act.
- 14. **Essential Plant Nutrient Dificiency.**—(1) In the event of any guaranteed analysis of fertilizer referred to in section 15(1) of the Act, one or more essential plant nutrient deficiency shall be determined by prescribed investigation allowance, and in order to fulfill the deficiency of a certain nutrient, any over guarantee of any other ingredient shall not be acceptable as its alternative.
- (2) The person responsible for the deficiency mentioned in sub-rule (1) shall be punished under section 15(2) of the Fertilizer (Management) Act, 2006.
- 15. **Issuance of specification**.—The highest allowable level of chemical pollutant in fertilizer. substance identical with fertilizer or raw materials shall be determined as per Part-A of Schedule-1, and the deficiency of essential plant nutrient shall be determined as per Part-B of Schedule-1.
